## Please review the following adoption policies and information.

**Microchip Implant** -- All cats and dogs have been implanted with a microchip for identification purposes. The microchip provides a permanent, positive identification should your pet become lost. It is important that you register any change of address, or contact numbers, in order to continue to benefit from implant.

**Free Council Registration** – All cats and dogs will be registered with the FCRC until the end of the current Council Registration period. It is your responsibility to maintain your pets registration beyond this term.

**Fourteen-Day Return Policy**—All pet adoptions are given a fourteen (14) day period during which time you may return the pet and receive a part reimbursement or exchange to a new animal that is more suited. No reimbursement will be given should the new transaction be less than the value of the first animal and should it be after 14 days. If this should occur, the balance will be considered a donation to the Society.

**Cash Refunds** -- No full cash refunds or charge credits will be given for returned animals. The full amount less 10% will be credited if the animal is returned in fourteen (14) days. Please think about your adoption decision carefully and thoroughly!

**Quarantine Period** – We strongly advise you to keep your newly adopted pet isolated from your existing pets until 10 days have passed since the Vaccination Date. (Puppies require Vaccinations at 6-8weeks, 12-14weeks and 16-18 weeks) The Society is unable to treat pets currently in your home which may have been exposed to illness from your newly adopted pet.

**Ownership Agreement** – As the new owner, you agree to take full responsibility for the care and wellbeing of this pet for its lifetime. Once the adoption is finalized, you will be responsible for all medical bills and decisions regarding this animal. If these conditions aren't met the society has the right to reclaim the animal.

Responsible Ownership – Should you experience any difficulties with your pet, or it's behaviours, it is your responsibility to seek appropriate remedies or training, to give your pet it's best chance to fit into your home. For information or advice in relation to your pet, training or other issues, please feel free to contact us at any time. (In the event that you find yourself unable to continue to provide adequate care for your pet, please return it to the Refuge)
